To start a quote, you will need to give us some basic information:

Machine Information

- Make, Model, and Year
- Current Engine Hours
- Serial Number *(Not required to get a quote, but required to request purchase)*

Coverage Desired

- End Date of current coverage or desired Start Date
- Years of coverage needed *(1 - 5 years)*
- Hours of coverage desired *(Choose how best to describe what you need from one of three ways: 1) Additional hours, 2) Ending hours, or 3) Average hours used per year)*
- Deductible *(\$0, \$250, \$500, or \$1,000)*
- Plan selected *(Powertrain, Powertrain + Hydraulic, Powertrain + Hydraulic + Platform)*
- You may request a higher Limit of Liability
- You may request additional quote options, as needed

To request the purchase of a contract you will be required to provide the following:

Inspection Reports

- Any machine with less than 30 days of current coverage requires an inspection
- Your technician can use the same forms used to qualify units for manufacturer coverage
- We do not require fluid samples to be sent in for 3rd party analysis
- We **DO** expect fluids to be changed per interval and verified to be free of foreign materials
